Section 8 - Precautions for Safe Handling and Use

Steps to be Taken in Case Material is Released or Spilled:

Wear protective equipment. Sweep up, place in a bag and hold for waste disposal. Avoid raising dust. Ventilate area and wash spill site after material pickup is complete.

Waste Disposal Method:

Dissolve or mix the material with a combustible solvent and burn in a chemical incinerator equipped with an afterburner and scrubber. Observe all federal, state and local environmental regulations.

Precautions to Be Taken in Handling and Storage:

Mechanical exhaust required. Do not breath dust. Avoid contact with eyes, skin and clothing. Keep tightly closed. Store in a cool dry place. Store at -20° C.
