## ***Section 6 - First Aid Measures***

### **Inhalation:**

### **ROUTE OF EXPOSURE**

## ***Section 8 - Precautions for Safe Handling and Use***

### **Steps to be Taken in Case Material is Released or Spilled:**

Wear respirator, chemical safety goggles, rubber boots and heavy rubber gloves. Sweep up, place in bag, and hold for waste disposal. Avoid raising dust. Ventilate area and wash spill site after material pickup is complete.

### **Waste Disposal Method:**

Dissolve or mix material with a combustible solvent and burn in a chemical incinerator equipped with an afterburner and scrubber. Observe all federal, state, and local environmental regulations.

### **Precautions to Be Taken in Handling and Storage:**

Store in a cool, dry place. Avoid prolonged, repeated exposure. Wash after handling. Wear chemical safety goggles, chemical resistant gloves, and NIOSH/OSHA-approved respirator.

Water spray, carbon dioxide, dry chemical powder or appropriate foam.
