### 6. ACCIDENTAL RELEASE MEASURES

#### Personal precautions

#### Methods and materials for containment and cleaning up

### 7. HANDLING AND STORAGE

#### Precautions for safe handling

#### Conditions for safe storage

Keep container tightly close in a dry and well-ventilated place. Store at 2-8°C under inert atmosphere.

#### Respiratory protection
