Inhalation:

Health Hazards (Acute and Chronic):

ROUTE OF EXPOSURE Skin Contact: May cause skin irritation. Skin Absorption: May be harmful if absorbed through the skin. Eye Contact: May cause eye irritation. Inhalation: May be harmful if inhaled. Material may be irritating to mucous membranes and upper respiratory tract. Ingestion: Toxic if swallowed. To the best of our knowledge, the chemical, physical, and toxicological properties have not been thoroughly investigated. A metabolite of Amiodarone, a non-selective ion channel blocker.

Section 8 - Precautions for Safe Handling and Use

Steps to be Taken in Case Material is Released or Spilled:

wear respirator, chemical safety goggles, rubber boots and heavy rubber gloves. Sweep up, place in bag and hold for waste disposal. Avoid raising dust. Ventilate area and wash spill site after material pickup is complete.

Waste Disposal Method:

Dispose of in accordance with all federal, state and local environmental regulations.

Precautions to Be Taken in Handling and Storage:

Store in a cool, dry and well ventilated area. Keep all containers securely closed when not in use.
