4. FIRST AID MEASURES**General advice**

6. ACCIDENTAL RELEASE MEASURES**Personal precautions**

7. HANDLING AND STORAGE

Precautions for safe handling

Keep container tightly closed in a dry and well-ventilated place. Containers which are opened must be carefully resealed and kept upright to prevent leakage. Light sensitive. Moisture sensitive. Store at room temperature.
