2. Composition, Information or Ingredients

Hazardous Ingredients: α -(Trifluoromethyl)benzhydrol

3. Hazard Identification

Irritant. Avoid prolonged exposure. Do Not breathe vapor. Use caution when handling. Exposure to any chemical should be limited. To the best of our knowledge, the health hazards of this product have not been fully investigated. This product is provided solely for the purpose of research and development.

4. First Aid Measures

Eye Contact: Check for and remove any contact lenses. Immediately flush eyes with clean, running water for at least 15 minutes while keeping eyes open. Cool water may be used. Seek medical attention.

Skin Contact: After contact with skin, wash with generous quantities of running water. Gently and thoroughly wash affected area with running water and non-abrasive soap. Cool water may be used. 6. Accidental Release Measures

Steps to be taken if material is spilled or otherwise released into the environment: Wear appropriate respirator, impervious boots and heavy rubber (or otherwise impervious) gloves. Scoop up solid material or absorb liquid material and place into appropriate container. Ventilate area and wash affected spill area after pickup is complete. Wash skin immediately with plenty of water. Place solid or absorbed material into containers and close for disposal.
