# CD63 CRISPR/Cas9 KO Plasmid (h2): sc-400061-KO-2



The Power to Question

### **BACKGROUND**

The Clustered Regularly Interspaced Short Palindromic Repeats (CRISPR) and CRISPR-associated protein (Cas9) system is an adaptive immune response defense mechanism used by archea and bacteria for the degradation of foreign genetic material (4,6). This mechanism can be repurposed for other functions, including genomic engineering for mammalian systems, such as gene knockout (KO) (1,2,3,5). CRISPR/Cas9 KO Plasmid products enable the identification and cleavage of specific genes by utilizing guide RNA (gRNA) sequences derived from the Genome-scale CRISPR Knock-Out (GeCKO) v2 library developed in the Zhang Laboratory at the Broad Institute (3,5).

## **CHROMOSOMAL LOCATION**

Genetic locus: CD63 (human) mapping to 12q13.2.

# **PRODUCT**

CD63 CRISPR/Cas9 KO Plasmid (h2) is designed to disrupt gene expression by causing a double-strand break (DSB) in a 5' constitutive exon within the CD63 (human) gene.

CD63 CRISPR/Cas9 KO Plasmid (h2) consists of a pool of 3 plasmids, each encoding the Cas9 nuclease and a target-specific 20 nt guide RNA (gRNA) designed for maximum knockout efficiency. Each vial contains 20  $\mu g$  of lyophilized CRISPR/Cas9 Plasmid DNA. Suitable for up to 20 transfections. Also see CD63 HDR Plasmid (h2): sc-400061-HDR-2 for selection of cells containing a DSB induced by CD63 CRISPR/Cas9 KO Plasmid (h2).


# STORAGE AND RESUSPENSION

Store lyophilized plasmid DNA at 4° C with desiccant. Stable for at least one year from the date of shipment. Once resuspended, store at 4° C for short term storage or -20° C for long-term storage. Avoid repeated freeze thaw cycles.

Resuspend lyophilized plasmid DNA in 200  $\mu$ l of the provided ultrapure, sterile, DNase-free water. Resuspension of the plasmid DNA makes a 0.1  $\mu$ g/ $\mu$ l solution in a 10 mM TRIS EDTA, 1 mM EDTA buffered solution.

#### **APPLICATIONS**

CD63 CRISPR/Cas9 KO Plasmid (h2) is recommended for the disruption of gene expression in human cells.



## **SUPPORT REAGENTS**

For optimal reaction efficiency with CRISPR/Cas9 KO Plasmids, Santa Cruz Biotechnology's UltraCruz<sup>®</sup> Transfection Reagent: sc-395739 (0.2 ml) and Plasmid Transfection Medium: sc-108062 (20 ml) are recommended. Control CRISPR/Cas9 Plasmid: sc-418922 (20 µg) negative control is also available.

## **GENE EXPRESSION MONITORING**

CD63 (E-12): sc-365604 is recommended as a control antibody for monitoring of CD63 (human) gene expression prior to and after knockout by Western blotting (starting dilution 1:200, dilution range 1:100-1:1000) or immunofluorescence (starting dilution 1:50, dilution range 1:50-1:500).
