# TIGD4 siRNA (h): sc-89321



The Power to Question

#### **BACKGROUND**

TIGD4 (tigger transposable element-derived protein 4) is a 512 amino acid protein belonging to the tigger transposable element derived protein family. Localizing to nucleus, TIGD4 contains one DDE domain, one HTH CENPB-type DNA-binding domain, and one HTH psq-type DNA-binding domain. TIGD4 undergoes phosphorylation upon DNA damage, and is related to DNA transposons from nematodes and fungi. The gene encoding TIGD4 maps to human chromosome 4q31.3. Chromosome 4 represents approximately 6% of the human genome and contains nearly 900 genes. Notably, the Huntingtin gene, which is found to encode an expanded glutamine tract in cases of Huntington's disease, is on chromosome 4. FGFR-3 is also encoded by a gene that maps to human chromosome 4 and has been associated with thanatophoric dwarfism, achondroplasia, Muenke syndrome and bladder cancer. Chromosome 4 is also tied to Ellis-van Creveld syndrome, methylmalonic acidemia and polycystic kidney disease.

# CHROMOSOMAL LOCATION

Genetic locus: TIGD4 (human) mapping to 4g31.3.

#### **PRODUCT**

TIGD4 siRNA (h) is a pool of 3 target-specific 19-25 nt siRNAs designed to knock down gene expression. Each vial contains 3.3 nmol of lyophilized siRNA, sufficient for a 10  $\mu$ M solution once resuspended using protocol below. Suitable for 50-100 transfections. Also see TIGD4 shRNA Plasmid (h): sc-89321-SH and TIGD4 shRNA (h) Lentiviral Particles: sc-89321-V as alternate gene silencing products.

For independent verification of TIGD4 (h) gene silencing results, we also provide the individual siRNA duplex components. Each is available as 3.3 nmol of lyophilized siRNA. These include: sc-89321A, sc-89321B and sc-89321C.

#### STORAGE AND RESUSPENSION

Store lyophilized siRNA duplex at -20° C with desiccant. Stable for at least one year from the date of shipment. Once resuspended, store at -20° C, avoid contact with RNAses and repeated freeze thaw cycles.

Resuspend lyophilized siRNA duplex in 330  $\mu$ l of the RNAse-free water provided. Resuspension of the siRNA duplex in 330  $\mu$ l of RNAse-free water makes a 10  $\mu$ M solution in a 10  $\mu$ M Tris-HCl, pH 8.0, 20 mM NaCl, 1 mM EDTA buffered solution.

#### **APPLICATIONS**

 ${\sf TIGD4}$  siRNA (h) is recommended for the inhibition of  ${\sf TIGD4}$  expression in human cells.

# **SUPPORT REAGENTS**

For optimal siRNA transfection efficiency, Santa Cruz Biotechnology's siRNA Transfection Reagent: sc-29528 (0.3 ml), siRNA Transfection Medium: sc-36868 (20 ml) and siRNA Dilution Buffer: sc-29527 (1.5 ml) are recommended. Control siRNAs or Fluorescein Conjugated Control siRNAs are available as 10 µM in 66 µl. Each contain a scrambled sequence that will not lead to the specific degradation of any known cellular mRNA. Fluorescein Conjugated Control siRNAs include: sc-36869, sc-44239, sc-44240 and sc-44241. Control siRNAs include: sc-37007, sc-44230, sc-44231, sc-44232, sc-44233, sc-44234, sc-44235, sc-44236, sc-44237 and sc-44238.

### **RT-PCR REAGENTS**

Semi-quantitative RT-PCR may be performed to monitor TIGD4 gene expression knockdown using RT-PCR Primer: TIGD4 (h)-PR: sc-89321-PR (20  $\mu$ l). Annealing temperature for the primers should be 55-60° C and the extension temperature should be 68-72° C.
