GPSM3 siRNA (h): sc-95457



The Power to Question

BACKGROUND

GPSM3 (G-protein-signaling modulator 3), also known as AGS4, G18 or NG1, is a 160 amino acid cytoplasmic protein that contains three GoLoco domains. Expressed in liver, heart, lung and placenta, GPSM3 functions to interact with and regulate the activation of $G_i \, \alpha$ proteins, possibly playing a role in signaling cascades throughout the body. The gene encoding GPSM3 maps to human chromosome 6, which contains 170 million base pairs and comprises nearly 6% of the human genome. Deletion of a portion of the q arm of chromosome 6 is associated with early onset intestinal cancer, suggesting the presence of a cancer susceptibility locus. Additionally, Porphyria cutanea tarda, Parkinson's disease, Stickler syndrome and a susceptibility to bipolar disorder are all associated with genes that map to chromosome 6.

CHROMOSOMAL LOCATION

Genetic locus: GPSM3 (human) mapping to 6p21.32.

PRODUCT

GPSM3 siRNA (h) is a pool of 2 target-specific 19-25 nt siRNAs designed to knock down gene expression. Each vial contains 3.3 nmol of lyophilized siRNA, sufficient for a 10 μM solution once resuspended using protocol below. Suitable for 50-100 transfections. Also see GPSM3 shRNA Plasmid (h): sc-95457-SH and GPSM3 shRNA (h) Lentiviral Particles: sc-95457-V as alternate gene silencing products.

For independent verification of GPSM3 (h) gene silencing results, we also provide the individual siRNA duplex components. Each is available as 3.3 nmol of lyophilized siRNA. These include: sc-95457A and sc-95457B.

STORAGE AND RESUSPENSION

Store lyophilized siRNA duplex at -20 $^{\circ}$ C with desiccant. Stable for at least one year from the date of shipment. Once resuspended, store at -20 $^{\circ}$ C, avoid contact with RNAses and repeated freeze thaw cycles.

Resuspend lyophilized siRNA duplex in 330 μ l of the RNAse-free water provided. Resuspension of the siRNA duplex in 330 μ l of RNAse-free water makes a 10 μ M solution in a 10 μ M Tris-HCL, pH 8.0, 20 mM NaCl, 1 mM EDTA buffered solution.

APPLICATIONS

GPSM3 siRNA (h) is recommended for the inhibition of GPSM3 expression in human cells.

SUPPORT REAGENTS

For optimal siRNA transfection efficiency, Santa Cruz Biotechnology's siRNA Transfection Reagent: sc-29528 (0.3 ml), siRNA Transfection Medium: sc-36868 (20 ml) and siRNA Dilution Buffer: sc-29527 (1.5 ml) are recommended. Control siRNAs or Fluorescein Conjugated Control siRNAs are available as 10 µM in 66 µl. Each contain a scrambled sequence that will not lead to the specific degradation of any known cellular mRNA. Fluorescein Conjugated Control siRNAs include: sc-36869, sc-44239, sc-44240 and sc-44241. Control siRNAs include: sc-37007, sc-44230, sc-44231, sc-44232, sc-44233, sc-44234, sc-44235, sc-44236, sc-44237 and sc-44238.

RT-PCR REAGENTS

Semi-quantitative RT-PCR may be performed to monitor GPSM3 gene expression knockdown using RT-PCR Primer: GPSM3 (h)-PR: sc-95457-PR (20 μ l). Annealing temperature for the primers should be 55-60° C and the extension temperature should be 68-72° C.
